

Harrison House Fall iPad Giveaway Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. SWEEPSTAKES IS OPEN ONLY TO CITIZENS OF THE UNITED STATES AND CANADA (excluding the Province of Quebec) AGE 18 OR OLDER. The Harrison House Fall Giveaway opens July 26, 2010 and closes October 31, 2010. The winner's name will be randomly drawn from all entries received. Participation constitutes entrant's full unconditional agreement and acceptance of these Official Rules. Sweepstakes is sponsored by Harrison House Publishing.

ELIGIBILITY: Employees, independent contractors, officers, and directors of Sponsor, its affiliates, subsidiaries, advertising, promotion, and fulfillment agencies, legal advisors, and the immediate family members and persons living in the same household of such persons are not eligible to participate in the Sweepstakes.
